- 2. Minutes of April 17 meeting. Paragraph 3 amended to indicate that financial report was discussed. - 5. Victor discussed having record retention policy, NRHS has such a policy and it will be followed by the Fund. Discussion of having Walter Zullig serve as Inspector General for the Fund as he does for NRHS.

- 6. Fund Raising was mentioned and it was agreed would be a main discussion item for the October Board Meeting. It looks like the next time for an inperson board meeting might be next Summer at the convention or at the Fall Board meeting at Ronkonkoma, LI NY.
- 7. Financial Committee was discussed as being a committee of the whole for NRHS Fund. Discussion included using Facebook fund raising. Cynthia discussed getting a collection mechanism before we discuss going forward with how the Fund can promote donations. An extensive discussion was held regarding this. Discussion also included using NRHS website and what improvements need to be made for this purpose. It was agreed that Cynthia, Bob Bitzer, Bob Ernst and Victor would get together on this issue and determine a path forward.
- 8. Investment report shows \$475,000 hopefully growing. Agreed that \$44,000 will be transferred to NRHS for Grants for this year. Discussed electronic transfer being set up. To be determined by Bob Bitzer and Bob Heavenrich handling this.
- 9. Discuss eblast regarding Heritage Grants fund raising issues.
- 10. Next meeting to be held in October.
