#### 3. NRHS Fund Financial Report / Audit Report / Expense Report

NRHS Fund Treasurer Bob Bitzer reviewed the NRHS Fund financial reports. (Appendix A) Currently all NRHS Fund expenses are being paid by the NRHS. The NRHS Fund should be able to pay its own expenses. A policy needs to be agreed upon by the NRHS Fund Board and the NRHS Board.

The NRHS Fund still has a \$50,000 loan open with the NRHS. This loan is the start-up funds

required at the time of the NRHS Fund creation. The NRHS should change this from a loan to an expense.

There was discussion on moving all NRHS donation accounts into the NRHS Fund accounts.

There is a concern on how the auditors at PGA will approve of the expensing the loan and moving the funds between the NRHS and NRHS Fund.

**Motion:** Wes Ross motioned and James Badgley seconded to solicit an opinion from PGA on the expensing of the \$50,000 loan and the transfer of NRHS donation accounts to the NRHS Fund accounts. Passed by voice vote.

No funding requests were brought to the Board.

### 4. Fundraising for NRHS Programs

A donation ask letter will be included with the NRHS Annual Membership Meeting Notice and Proxy mailing. Marlin Taylor will create this letter and have it to Al Weber for the mailing.

NRHS President AI Weber is encouraging the Trustees of the NRHS Fund to work on grant applications. A standard letter should be created to accompany the grant applications. Al also encouraged the Trustees to attend next year's Railroad Day on the Hill. It is a way to meet with the Representatives and Senators and discuss the activities of the NRHS.

Wes Ross has finalized the 2018 CFC application. A team should be developed to attend the various CFC Kick-Off Rallies held around the country at federal offices to promote donations to the groups approved for CFC donations.
