REPORTS

Vice President – Frank Cornelius. Frank thanked Tony and the Board of Directors for electing him, Vice President. One of his objectives is to work with Dave Baniewicz on online sales.

- **a. Treasurer** Bob Bitzer. He advised all reports had been sent out on August 31. It included a cover letter, and three reports. The convention report is not complete yet.
- **b. Fund** Robert Emst. The report was given at the Advisory Council meeting earlier today. The financial report will be out soon. The committee is still investigating how to generate funds using Facebook. Also, an exploratory committee has been formed to investigate other means of obtaining donations.
- **C.** Advisory Council Richard Shulby. They had 32 members present: 13 at the meeting and 19 online.
 - 1. They would like to see a committee formed to aid Marlin with the film library.
 - 2. Share the Wealth has been disbanded
 - 3. They are endorsing the Black Hawk chapter's celebration in October 2023 of the first train to Chicago.
 - **4.** They would like to see Advisory Council meetings in addition to BOD meetings on the same day.
 - **5.** A committee to explore reinstating regional representation to further communicate with other chapters and At-Large members.
- **d. General Counsel** John Fiorilla. John has renewed the trademark for both RailCamp and the NRHS logo with the lines through it. He met with the proposed new auditors. The grants have been completed.
- **e. Historic Plaques** Walter Zullig. Nothing to really report. Two places expressed interest and he contacted them. He hasn't heard back from them. He stated that if anyone know of interested parties to please let him know.
- **f. Heritage Grants** Charlie Webb. In the process of doing an after-action review. Also looking at consolidating some of the paperwork. The application for 2023 should be online in October/November. The deadline is changed to January from February. They are also investigating using Electric Fund Transfer instead of mailing checks. They are changing the cap



- from \$5000 to \$10,000. When the project is completed, they will request a photo and description of the work. Those will be sent to both Val and Skip for publication.
- **g. RailCamp** Tony White. Working with Amtrak as they have a new boss. RailCamp is going forward in 2023 both East and West. Waiting to hear from Strasburg as to when Thomas will be there. Dates are not set yet.
- h. News Val Hoski. She gave the report at the Advisory Council meeting, and it is online. The NHRS sends out 3 black & white mailed issues, and 6 online color issues. The February, April, June, August, and August supplement are online, and the March and May issues have been mailed. A special thanks to Eileen Weber and Elizabeth Guenzler for their assistance.
- **i. Discount List** Wes Ross. The discount list started 20 years ago. It provides a list to NRHS members of rail attractions that are free and fee. It went well until Covid. The list includes all whether offering a discount or not. Many of the attractions are asking for membership brochures. Approximately 10,000 were sent in 2022. This will continue in 2023 **CFC.** This is the Combined Federal Campaign. It provides all federal workers to make donations to charities via payroll deduction. It runs from September thru January 15. It costs us \$1020 per year to do this.

 The donations in past years were: 2021 \$1583.50

2022 \$2,000 2019 \$3,800 2018 \$3,600 2017 \$2,200

Members need to make this better known to friends and family to encourage donations to the NRHS. It does make money for us, so he recommends we go forward with this program. It's available to retirees and current employees.

- **j. Inspector General** Walter Zullig. He has been working with the Heritage Grants Committee towards the completion of the projects. He has contacted the recipients and working on getting updated information from them.
- **k. Bulletin** Tony White. During Covid it was easier for writers to have the time to write articles. We are currently seeing less being sent. If anyone is interested in back issues, contact Jeff Smith. Al Weber stated that he also sends surplus issues to chapters that are having shows. He sends back issues only and includes brochures.
- **Membership** Hugh Harris. We have sent out 5400 Bulletins which is the easiest way to count membership. Membership expires 12/31. The numbers are staying the same, with maybe an increase of 100 per year.
- M. Photo Contest Mike Yuhas. He presented a "preview" slide show of the winners of the photo contest.

Convention Reports – John Goodman. John mentioned that he has had a lot of people saying that they miss the seminars at convention. He explained that they were usually paid for by donations or a group. Mike Yuhas stated that we need to find some sponsorships, either rail fans or from the Railroad industry. Fort Lauderdale, FL – Walter Zullig has done a lot of work on this location. The dates are either 9/1-5 or 9/8-13, 2023. The committee is still looking into hotels. The dates will be finalized once a hotel is determined. Trips so far will be the Sugar Express Railroad in Clewiston, FL. There is an option of a six-hour trip or a two hour one. After discussion a vote was taken, and the 6-hour trip was decided on.

Harrisburg, PA. The 2102 should be running by then. We would probably stay at a hotel in Harrisburg or the nearby area.

2025 Omaha. No details at this time.

Conferences – Bob Bitzer. Thanked Hugh Harris and the Arkansas-Boston Mountains Chapter for hosting the meeting. They are still working on the accounting. NRHS conferences are put on by the chapters. However, lately, a lot of the chapters are losing money or just breaking even. It was decided that in the future the NRHS will help the chapter with some of the finances.

The 2023 Spring conference with be a joint function with the R&LHS and the Sothern Pacific Railway Historical Society. The conference is being moved from Sacramento, CA to Reno/Sparks, NV. The host hotel will be the Nugget Hotel in Sparks. The hotel has just undergone a \$150 million renovation. All we have to do is set up. The rooms have been arranged for both the Advisory Council and the Board of Directors. R&LHS will handle the ticketing, it will all be a la carte. The dates are 5/15-21, our meetings will be held on 5/21. The Sparks location overlooks the UP yard. The registration package for us will probably be \$50. Their registration will be a sliding scale of \$99-\$129. They will collect all the monies. This is a way to develop a partnership with those organizations. Kevin Feeney made a motion to hold the Spring Conference in Conjunction with R&LHS, seconded by Skip Waters, passed.



A short discussion followed regarding the locations of conferences. Rather than looking for the chapters to sponsor, maybe schedule at an airport hotel for easy access.

NEW BUSINESS

Bob Bitzer stated that the local chapter did a great job, but they lost money. The NRHS has offered financial support one time in the past. After discussion, it was decided to offer up to \$6000 in support if necessary to the chapter. Motion made by Kevin Feeney, seconded by Skip Water, passed.

Budget-Bob Bitzer. Bob reviewed the budget. After review, Doug Scott asked if the funds for pins had been added to the budget. It was decided that half the pins would be ordered this year and the balance next year.

IT Budget-Dan Meyer. The virtual server needs an upgrade. Both the hardware and software need to be upgraded. The estimate is \$15,000. Skip Waters made a motion to amend the budget for these items, seconded by Kevin Feeney, passed

Audit Firms-John Fiorilla. Our current firm, RKL, is not working out. They are not getting our reports done in a timely fashion. John knew of this firm from some of his other customers. A group from the NRHS went to Syracuse to meet with the firm. Kevin Feeney also attended the meeting. He asked for names of current clients so that we could see how others felt about this firm. Kevin contacted them and received good answers from them. A plus for them is that we are working with a partner, not a manager. Bob Bitzer also spoke with them about the PA filings. They are a little higher then RKL, but it's fixed in the budget. The Fund recommends going with Bowers. Motion made by Ellen Scott to go with Bowers as the NRHS audit firm, seconded by Eric Fogg, passed.

John H. Emery Rail Heritage Trust – Tony White. They are looking for an NRHS person to be on their Board. We need someone that would be able to attend and chair this committee. Committee members are also needed.

NEON – Several board members have been meeting with NEON to see what they can and can't do for us. For the time being we will stay with NEON and see how things progress.

ANNOUNCEMENTS

Emblem Sales- Dave Baniewicz. Has items for sale in the back of the room. He is currently looking into selling NRHS items online.

A question came up regarding the remaining paintings that were to be auctioned and their location. Al Weber advised that they are with the auction company and will go on sale at the next auction. The appraised value is \$5500.

There being no further business, the meeting was adjourned at 5:22PM.

However, since there were more people running than could be elected, you should acknowledge the membership who voted and their faith in each one of us. We should also remember those not elected because they like you wanted to serve the Society.

Thank you to the Electoral Committee of Patti Webb, Bob Ernst, Joe Maloney, and John Fiorilla for the work they had to do in order to find candidates, process the ballots, count and certify them.

I would like us to take a minute to remember those we knew at the National, Chapter, At-Large levels, and their families and loved ones. Please remember all who have moved on including Bob Heavenrich, Bill Howes, Dell Kittendorf, Marty Swan, and Jim Wrinn.
