Plenary Session Spring Meeting Saturday, May 3, 2025

Minutes approved July 17, 2025

President Tony White called the meeting to order at 9:05AM. He thanked the George L. Carter Chapter for hosting the meeting. He then asked for a moment of silence for those who have passed.

Safety Briefing – John Fiorilla. There are no scheduled fire alarms today. John advised what to do if an alarm is heard and where to exit. He asked for a volunteer for First Aid and the location of an AED if needed. If there is a tornado, exit the from and go to the left.

President White thanked the George L Carter chapter for the weekend's activities.

Reports-

Rail Attractions – Wes Ross. See Appendix 1. Wes reported that there are 170 attractions listed. He has asked the attractions if they will distribute NRHS brochures. 9000 brochures will be sent out. There are 40 new locations. If anyone knows of an organization that wants to be listed, please get the info to Wes.

Historic Plaque Committee – Walter Zullig. See Appendix 2. There have been three requests that he is working on.

Inspector General – Walter Zullig. See Appendix 3. He is dealing with one matter that involves a grant. The Twin Forks Chapter is having a membership issue. They have very few members that belong to the national chapter. He is currently working on this. Ron Gawedzinski questioned who reviews the grants not heard from? Walter advised the committee chairs investigates these. The last review of the outstanding grants was done last year. This matter remains pending.

Emergency Board Meeting April 13, 2025 – Tony White. An emergency board meeting was convened regarding the 2025 Convention. A presentation was given by the committee chairs and voted on. The proposal was passed, and the committee will continue with the plans.

Convention Committee – Mike Yuhas, Eric Fogg. See Appendix 4. They are excited to bring this convention to Lansing, MI. The location of the hotel was central to the. Trips planned. The convention will be held July/12-17. The hotel availability in this area was very good. Amtrak serves this area. They received bid from 5 hotels but chose The Graduate. This hotel is part of the Hilton family. The room rate is \$135 per night and free valet parking. Mike presented slide showing the interior of the hotel. He then described

the trips planned for the week (see Appendix 4). He listed the helpers for the Convention:

The hotel is not ready for reservations yet. Notification will be sent out when reservations can be taken.

Val Hoski stated that the hotel is I East Lansing and its very different from Lansing. There are lots of walkable place nearby.

Conferences – Bob Bitzer. Thanked everyone for coming. He also thanked the members of the George L. Carter Chapter that put this together: Scott, Carson, and Pam. We had 70 plus people attending the conference. We had great programs. He asked for a round of applause for the chapter.

The Fall Conference will be held in Wisconsin. Mike Yuhas advised that it will be held on October 3 and 4. We will ride the East Troy Electric Railroad, meetings will be on Saturday. The chapter is celebrating it's 75 anniversary at their annual banquet. The banquet will be at the Polish Community Center.

Bob advised that we need more support from the chapters, for meetings and chapters and national in general.

Heritage Grants – Charlie Webb. See Appendix 5. They processed 45 applications for the \$150,000 to be given out. George Hickok receives all the applications. George was hospitalized which slowed down the process. They hope to have it done shortly.

The Twin Forks Chapter received their grant in 2020. Due to Covid they requested an extension which was granted to 2025. The committee does get progress reports thought the process. They hope to have everything finalized by May when letters will be sent to the winners and losers. Interim reports is part of the process.

Film and Slide Preservation – Mitch Dakelman, Marlin Taylor, Tom Coughlin. See Appendix 6. Marlin reported that they need help. They now have a contract for the film and slide storage. They are going through renovation to provide better preservation. They signed a contract and gave them \$2000. Last week they signed a contract with a film company for a 14 second clip for a movie for \$500.

Membership – Charlie Webb for Patti Webb. Appendix 7. A report was included in the packet. Membership is down 4.89%. All areas are down. The committee is against raising dues. Tony stated that we get new members through Heritage Grants, RailCamp, Historic Preservation, etc. As members come in, members also go out. Jon Baake asked are we tracking where new members are coming from. Mike replied that they are tracking. Ward stated that members join throughout the year and membership

is not showing a decrease in income. Discussion followed. Joh Baake requested the results of the tracking at the next meeting.

Membership Awards – Doug Scott. See Appendix 8. Report is online.

Membership Brochures – Jon Baake. See Appendix 9. 9000 have been requested and will be sent out in May and June. He gives out approximately 15,000 per year. He has a supply to give out to anyone who needs them.

RailCamp – Becky Gerstung. See Appendix 10. Tony White reported for Becky Gerstung. Both camps are full. They are still having issues with Amtrak regarding dates.

Historic Preservation Award – Mike Yuhas. See Appendix 11. The award presentation will be May 21.

Treasurer's Report – Bob Bitzer. The Board has received the reports. He introduced Ward Wells. Ward has taken over the responsibility for Quick Books. They are now generating complete Financial Reports which have been sent to the board. With the help of our comptroller, they are up to date and now doing all work in house. Bowers and Company, our auditors, will be used for our 990s.

Jon Baake asked about the \$41,000 shortfall in the budget. Bob explained he's not worried as there are ways to cover this. Tony also interjected that we need to remember that dues come in on a rolling basis rather than all at once. Therefore, numbers will look different from those in the past. Discussion followed regarding past budgets and ways to adjust.

NRHS Fund – Bob Ernst. We have \$1,340,952 in the Wells Advisor Account and \$41,151 in checking. Money from donations go into the Fund while credit card items go directly to the NRHS. There is a good chunk of NRHS Unrestricted donations in the NRHS accounts, not the Fund. They will be doing a transfer for Heritage Grants. It will be about \$135,000 which will include \$50,000 from the Samuel Freeman Trust. The balance will come from unrestricted donations. The Fund is currently looking for a comptroller. They are working with Dawn for an update on the web regarding donations.

General Counsel – John Fiorilla. See Appendix 12. An officers meeting was held at his NJ office. In attendance were Tony White, Ellen Scott, Bob Bitzer, Bob Ernst; Via Zoom were Scott Andes, Joe Moloney, Ward Wells, Mike Yuhas, and Eric Fogg. The meeting discussed policy issues and the proposed convention later this year. The General Counsel gives advice to the NRHS President and the Fund President on any issues that come up. He also gives advice to the committee chairs. He also fields questions from the chapters and gives general advise. They do not represent the chapters. All contracts are reviewed by the General Counsel. A resolution was needed to be written for the Winkler Estate, and sent to Ellen Scott, the secretary to be signed and sent.

The Plenary Session was adjourned at 10:39 AM.

2025 Directory of Rail Attractions

The 2025 edition of the NRHS Directory of Rail Attractions will be released electronically and posted on the NRHS Web Site in May. This edition will be the 26th that Shirley and I have produced since 2000. This year's edition contains over 170 rail attractions and museums across the country. We begin this process in January, by sending out invitations to a large mailing list of attractions. Each one is asked if they would like to be listed, at no charge, and if they would be willing to offer NRHS members a discount. All attractions that respond are listed, whether, or not, they offer a discount. Attractions that offer a discount, or are free, are listed in BOLD FACE type. All attractions that are related to NRHS Chapters are identified.

This list serves two major functions for the NRHS. Both of these functions are important, and they relate to two separate areas of our organization. The first function is that the directory provides members with a listing of many attractions, across the country, which they may chose to visit during the year, and even, possibly receive a discount. The second reason is less apparent; but very useful to our organization. In our invitation, we ask each attraction if they would be willing to display our NRHS brochures at their site. Over the past few years, over 350 different sites have requested brochures. Jon Baake, has volunteered to send brochures to each attraction, each year. This is a great way for the NRHS to be introduced to new and different audiences. This year, participating organizations have requested over 8,500 brochures. These brochures will be distributed by Jon Baake in late May or early June. This year, a total of 31 new sites have requested brochures that have not previously handled them. This is a great way for us to publicize the NRHS.

Report of Historic Plaque Committee

The Historic Plaque Committee has been quite busy since our last report.

First, we have approved the proposal for a plaque at Tunnel #6 on Donner Summit. We had a little delay with this project as once the language had been agreed upon and we were ready to place the order we discovered that our long-term plaque manufacturer in Pennsylvania had just gone out of business. After a search we located a manufacturer near Chicago. The plaque now has been manufactured and shipped to an officer of the Donner Summit Historical Society in Truckee, CA. The dedication is expected to take place during mid-June.

The second project was a plaque for a relocated turntable for the Oregon Rail Heritage Center in Portland, OR. The turntable had been at the former SP roundhouse in Brooklyn, OR, near Portland and was donated to the ORHC by Union Pacific. The turntable's 100th Anniversary was observed last year. The Pacific Northwest Chapter sponsored the plaque and agreed to pay half the cost of manufacture and shipping. The plaque is being manufactured and the dedication is planned for May 10, 2025.

We also have had a plaque request from the new Wichita Valley Chapter in Texas. The subject is two large historic urns that had been at the entrance to the former railroad station at Wichita Falls, TX. At present we are reviewing this matter with Chapter officers.

Report of the convention committee Submitted by Eric Fogg and Mike Yuhas • May, 2025 The convention will be headquartered in Lansing, Michigan, in July. Lansing was chosen for a couple reasons:

- 1. It is central to the venues of our daily excursions
- 2. It is a college town, which suggested a large inventory of hotel rooms
- 3. It is served by Amtrak

Meeting Solutions, our meeting consultant, obtained aggressive proposals from five hotels in town. We ultimately chose the Graduate (by Hilton), which is directly across the street from the campus of Michigan State University. Sleeping room rate is \$134 per night, plus taxes; free valet parking is included. The hotel opened in 2021. The tentative convention itinerary:

- Saturday, July 12: Opening reception, featuring a compelling speaker discussing a relevant railroad topic. Hors d'oeuvres, beer/wine.
- Sunday, July 13: Diesel-powered excursion over Great Lakes Central, operated by Steam Railroading Institute between Clare and Owosso.
- Monday, July 14: Steam-powered excursion operated by Fort Wayne Railroad Historical Society, Coldwater, Mich., to Ray, Ind., on Indiana Northeastern.

- Tuesday, July 15: A three-for in Elkhart, Ind.: visit to the National New York Central Museum; tour of Norfolk Southern's Elkhart Yard; tour of the Adams-Westlake factory.
- Wednesday, July 16: Visit to Greenfield Village including a screening of the giant screen movie "Train Time," and a tour of the restored Michigan Central depot in Detroit.
- Thursday, July 17: NRHS business meetings!

A "save the date" email was sent to all members on February 23, followed by an email with more detail on April 18. We are working with Choose Lansing (the local C&VB) to design, print and mail a postcard to all members. After all contracts have been signed, and event pricing confirmed, we'll begin relentless promotion via email and the NRHS website.

The committee recognizes that many members have definite ideas on the types of trips and activities offered in a convention. We would like to hear from you. The Film and Slide Archival Committee consists of just three members ... Mitch Dakelman, Tom Coughlin and Marlin Taylor. It has been functioning more or less behind the scenes for several years until recently, when we were finally in a position to begin offering the results of our efforts to members and the rail-loving public. This, of course, was the launch of our Photo Gallery via the NRHS website, followed more recently by establishing the Society's YouTube channel.

The Photo Gallery now offers more than 3,000 individual photos, all easily searchable by era, geographic area, etc. – thanks to the never-ending hard work of Mitch Dakelman. With each photo, its location is noted as well as when taken by name of photographer when known, and picture quality improved as much as possible, based on the original. He also is the person who cleans, repairs and edits where appropriate all the films prior to they being digitally scanned.

Our YouTube channel currently offers 61 films and has 1,500 subscribers. One film that was added just in January - a 1968 film of the Santa Fe Railroad, as shot by a NRHS member - has been viewed 8,800 times. The Society's YouTube channel is handled by Tom Coughlin ... for each 16 mm and 8 mm film, Tom does any needed editing and writes and adds an appropriate narrative prior to uploading the film.

One of the concerns Tom regularly expresses is having a protection backup copy of all of our digital files ... which we do not have at this time. Accomplishing this was recently advanced through our being donated what is known as a Synology network accessible storage server. Tom is in the process of acquiring the hard drives needed for it and expects to begin the backing up process over the next several weeks.

The NRHS has dozens of reels and hundreds of slides – likely it's hundreds of reels and thousands of slides, we haven't counted recently - which have been donated over the years, and we regularly receive new donations of large and small collections, having received several from members and non-members alike in recent months. So, our library of materials is constantly growing.

From time to time, we hear the question, "why aren't we able to see more of what's in the archives?" There is nothing more that the Committee members and your leadership would like than being able to double the number of slides and films available via our website – so why is that not occurring? Very simply ... MANPOWER! The NRHS is an all-volunteer organization, so we rely on our three-person committee to do the job, with zero outside help. As you've read above, it's not so simple as "scan and throw it up on the website" as someone suggested – real work in preparation is required! Hence, if you have any skills related to what's been described above ... would you consider donating them a few hours a week or month for the good of your *Society*?

We also receive requests from time to time to use a photo or film clip. Recently, German model train maker *Marklin* began offering a model of Western Maryland shay locomotive #5 ... photos of the real locomotive were included in their advertising, all coming from the NRHS archives. A contract has just been signed with a documentary film maker for use of film clips of train scenes from downtown Baltimore in 1955, taken from a film which the producers found on our YouTube channel.



Subj: Report of the NRHS Preservation Award Committee

Date: April, 2025

In late 2022, a small cohort of NRHS members developed the concept of an award to recognize a common carrier railroad for its historic preservation efforts. We reasoned that there is not a compelling business case for railroads to invest in preserving their history; our annual award gives an attaboy to a railroad that did just that.

Unlike the long-running NRHS Heritage Grants program, museums and tourist railroads are ineligible for this award. The preservation award honors *only* common carrier railroads that have undertaken significant historic preservation projects. Additionally, there is no financial component to this award.

Railway Age and Railway Track & Structures were recruited as our partners to increase the program's visibility into the railroad industry. The media support they have given has been robust, and welcome.

The 2025 award honoree has been selected. The award will be presented at the Railway Interchange trade show in Indianapolis on May 21.

The committee consists of NRHS members R. Victor Varney, Edward M. Berntsen, Larry Pearlman, Tony White, and Mike Yuhas; plus Bill Vantuono and David Lester from Railway Age and RT&S, respectively. The committee gratefully acknowledges the support of Dawn Holmberg and Trishah Woolley for their help in publishing the nomination forms on our website, and the enthusiasm of NRHS members who submitted nominations.

Previous honorees

2023 – Iowa Traction Railway, in recognition of their daily use of century-old electric locomotives and infrastructure

2024 – Union Pacific Railroad, recognizing the railroad's preservation and operation of historic steam and diesel locomotives to promote the railroad's heritage
