RailCamp – Another successful year! We had 37 campers this year. These kids, only one girl this year, came from 22 states. Of the 37 campers, 19 received full or partial scholarships. We have our usual reserved funds and out of the blue a guy offered to send a kid to camp. 6 NRHS chapters, 2 museums, a 4H model club, RPCA and Mass REA all helped kids this year. These young people are not only getting "the best week of their life", but they are introduced to employment opportunities beyond "driving the train". They learn first-hand at the various museums we include the value and importance of preservation and keeping railroad history alive. My chapter has past campers serving as a museum docent, a track replacement work crew member and even one of the very first RailCamp attendees at Steamtown, now working for VT Railway, just completed his second year as a counselor. Look at the age of your membership and ask yourself, "Who will carry on?" Get your young people involved. RailCamp is a great introduction. I have brochures available. Give them out at a chapter meeting, take them to the Boy Scout office or anywhere young people gather or leave them at a local museum or library. Not all the bills have been paid. I do not have a final financial report at this time. It looks like we did go over budget a little. Fortunately, we have reserved funds for this. Over \$10,000 was used to help campers. One of the biggest expenses is renting vans. We need a sponsor for some assistance with this.

RailCamp happens thanks to the planning and execution of two great programs. None of this would be possible without the dedication and tireless work of our directors. Tony White for East and John Cox for Northwest give countless hours of their time to make it all happen. All counselors and support staff are volunteers.

I especially want to thank Tony. He has been involved with this since 2015, the same year I joined the team. He has been there planning, visiting venues, the University, restaurants, making personal contacts with key people along the way. His friendly manner and respectful pursuit of the various ideas for the East program is reflected in the cooperation he has received from everyone. He has expressed his desire to step down, work in the background, share his knowledge and be there for support for a new Director.

No other issues have come to the IG's attention since the last Board meeting.


