Roll Call (Appendix A)

Sufficient members of the Board of Directors were present.

Minutes of the Spring Meeting in Lewisburg, PA were approved as corrected.

Report of the Chair Pro Tempore: Noted one more meeting for 2014, in Johnson City, TN.

Report by National President Greg Malloy. Called attention to special edition of NRHS Telegraph. Per request of a number of minutes the Telegraph was sent to all members.

Report from National Office presented by Greg Molloy. Office is working on dues renewal process for 2015. They are also working on items concerning RailCamp. Any questions concerning membership, etc. should be sent to info@nrhs.com copied to the President and the Secretary.

Old Business:

Chapter Newsletter exchange: Jeff Smith had no updates on this. Jim Pahris moved that this item be dropped. Seconded by Steve Segrist, item was dropped.

National Representative Job Description: Del Kittendorf presented proposed description and made motion to adopt. Seconded by John Simonton. Approved (Ref. Appendix B)

Convention Policy; Committee members were not present to present for discussion. A set of objectives was developed for consideration of the Board. Question raised concerning involvement of Chapters in conventions. G. Molloy noted that conventions could be operated in several ways, one of which is operation by a chapter or chapters. There exists multiple versions of proposed policy. Motion to table made and seconded. Tabled until Fall meeting.

Bulletin discussion points which were referred to Jeff Smith at the Lewisburg meeting. J. Smith stated that decision was made to publish an editorial explaining the approach used in deciding what to publish. This will be done in a future issue of the Bulletin. Question concerning a masthead listing of the officers of the Society. Decision has been made to leave these off.

Strategic Plan: Gary Reinbolt responded. The plan is intimately linked to be budget which will

be discussed in the Board meeting on Saturday.

Implementation of the 2015 dues process. Jeff Smith reported still in planning stages due to question of Fernly contract is resolved. Question of how members without means of renewing online could renew was again raised. In the end, everyone will be renewed electronically but for those unable to, the process will be handled through an intermediate party.

New Business

Discussion of affiliate membership. Suggested by Carl Jensen who was not present. Deferred to the Fall meeting.

Expense of the teleconferencing. Bob Ernst reported that it costs approx. \$3.00 per hour per user for the basic conference call. The costs of host hotel are unknown. He suggested that each person on the teleconference donate \$50.00 to help cover the costs.

Bill Chapman made presentation concerning RailCamp. It is go for both camps with a good attendance for both.

Open microphone

Steve Barry asked for more participation on the Facebook page. Also looking for preservation projects for the website. Both are very under utilized.

Al Weber reported that 56 chapters have Facebook pages.

Jeff announced a change on the admin site. The public folder and the advisory council folder are going to be merged since they are both open folders.
